GROUNDBREAKING CEREMONY FOR LARKFIELD ESTATES SEWER PROJECT

Steve Plamann (Aaction Rents and Chamber President), Aggie Maggio (Realtor @ Coldwell Banker), and Elizabeth Henry attended the Larkfield Estates Sewer Project groundbreaking on Saturday, January 11. This was a distinct milestone in the rebuilding of our community. The location was in the cul-de-sac in front of the home of block captains Tim and Sarah Preston. Speakers included Barry Dugan and Mike Thompson of Sonoma Water, Supervisor James Gore, and Gena Jacob of Larkfield Estates, who spearheaded the project. There were many families present and even the kids got in on the ground-breaking action!

The Groundbreaking Ceremony marked the beginning of construction of the Larkfield Estates Sewer Project. The project will extend sewer service to the Larkfield Estates neighborhood, which was destroyed during the 2017 Tubbs fire. Many homes in the Larkfield area were connected to septic systems.

In June of 2018 the Sonoma Water Board of Directors approved the plan to extend sewer service to the neighborhood, and also approved development of a financing plan to lessen the financial burden of connecting to sewer service. Larkfield Estates is within

the Airport/Larkfield/Wikiup Sanitation Zone, which is managed and operated by Sonoma Water. Construction of the \$5-million project gets under way in January 2020 and is scheduled for completion in October 2020.

The Spirit of Sonoma awards were created to honor individuals who contribute to the economic development of the communities in which they live, work and conduct business through donations of their time and expertise in support of local business and in helping others.

The Mark West Area Chamber of Commerce nominated member Willie Lamberson (Lamberson Tile) for his many contributions. Willie is a tireless individual who always concerns himself with the needs of others first. Willie has contributed immeasurably to the quality of life for numerous residents and visitors of Sonoma County and is a genuine pillar of strength in and around the Mark West / Larkfield / Wikiup area of Sonoma County. He constantly volunteers his time, and shares his passion in the support of local community projects and events.

The Mark West Area Chamber of Commerce recognizes Willie Lamberson for his many years of devotion to Sonoma County as well as his gracious efforts related to the 2017 wildfires that destroyed numerous homes and businesses in the Mark West/Larkfield/Wikiup Area. Willie started his business Lamberson Tile in Sonoma County in 1977. A lifetime Sonoma County resident, Willie attending St. Rose School, St. Vincent's High School, Santa Rosa Junior College, and Sonoma State University. Willie is an Army Veteran and also served in the Peace Corps in Togo, West Africa, from 1973 to 1975. Since returning from the Peace Corps nearly 45 years ago, Willie has been involved in many groups making positive changes including serving as an appointee of Sonoma County Supervisor James Gore on the Community Development Commission, Sonoma County Planning Commission, and Mark West Citizen's Community Advisory Board. After Willie lost his house to the Tubbs Fire of 2017, he has been a tireless and dedicated block captain assisting in the rebuilding of homes of 47 of his neighbors in the Wikiup/Carriage Lane Area of Santa Rosa. As a block captain, Willie has been a much appreciated and valuable conduit of information for his neighbors dealing in complicated matters regarding insurance, permitting, and contractor paperwork. His work has assisted many homeowners navigate the rebuilding process, thus ensuring smart and informed rebuilding decisions. Property owners cannot thank Willie enough for his help in the difficult process of rebuilding. Willie stated, "Losing my home to the wildfires was horrible, although the positive take-away from it was that it truly brought my neighbors and community together even more. I so appreciate the fact that we rebuilt and came back and now have a greater appreciation of life and of Sonoma County".

HOTEL OCCUPANCY CLIMBS IN NAPA, MARIN AND SOLANO COUNTIES IN DECEMBER, DIPS IN SONOMA COUNTY

2019 Hotel occupancy in the North Bay's four most popular counties for tourism wrapped up 2019 with mixed results, according to a hospitality industry data and analytics firm.

The figures, released Tuesday by STR, show that Napa County's lodging industry led its neighbors in total revenue for the year: \$446 million, up 5.1% from a year earlier. Sonoma County finished at \$326 million, down 2%; Marin County, \$141 million, up 1.9%; and Solano County, \$113 million, a 6.3% increase.

Revenue for the four counties rose 2.5% all together, to \$1.05 billion.

For December, Napa County's occupancy rate was 54.8%, up 1.1% compared with December 2018. The county since May has seen a month-to-month increase in occupancy compared with a year prior, with the exception of October, which was unchanged. The county average daily rate was \$254.12, down 0.3%, and monthly revenue totaled \$22 million, up 1%.

Sonoma County's occupancy rate in December was 62.1%, down 1.2% from a year earlier. Other than an 8% jump in November, the county's monthly numbers for the year were lower than the year before. Average daily rate last month was \$154.16, up 0.5% from a year prior, and revenue rose 0.1% to \$20 million.

The occupancy rate in Marin County last month was 65%, up 1.5% from a year earlier. The average daily rate was \$177.24, up 4.3% from December 2018, and revenue was \$9 million, a 5.8% increase from a year ago.

Solano County's occupancy rate in December was 54.1%, down 4.6% from a year earlier, while the average daily rate jumped by 2.5% to \$93.08.
