Conservation is an important value for all of us here in Sonoma County. California American Water is proud of the work we have done in recent years to manage our water resources more efficiently and provide customers with the tools and information they need to use water wisely and reduce water use. Some of our recent accomplishments include:

- Our rebate program for clothes washers and toilets began in 2005. Last year, customers received over \$3000 for replacing 19 washing machines and 14 toilets with water saving models
- Regular participation at community events to encourage wise water use
- Entered into a Water Conservation Agreement with Sonoma County Water Agency (SCWA) to access additional conservation support and expertise
- 12.9% reduction in water use between July and October 2007 compared to 2002-2006 average water use
- Reduced reliance on purchased water from SCWA from 167,000,000 gallons in 2006 to 135,000,000 gallons in 2007. This year we are on track for a similar reduction
- Establishment of the Londonberry Drive Garden which showcases water-wise drought resistant gardening

Recently, the California Public Utilities Commission increased the conservation budget for the Larkfield District. That's a positive development, because all of us can do more to conserve water. Currently we:

- Are collaborating with the Mark West Chamber of Commerce to sponsor and install a second water wise drought tolerant garden
- Sponsor a water and energy use curriculum for 5th and 6th graders at Mark West Union School District campuses
- Offer residential water use surveys for all customers
- Provide specialized water use surveys for business and irrigation accounts
- Have rebates and free water saving devices available to all customers
